1. The award shall be known as '**Dr.S.S. Hayreh award**'.
2. The award will be given once in two years.
3. The award will be in the form of a citation and certificate.
4. The awardee will be required to present his/her work at the annual conference of vitreo retinal society of India, for a duration not exceeding 20 minutes.

5. The award will be given to an Ophthalmologist of Indian origin working in India or outside for outstanding basic or clinical research work in the field of retina and vitreous. The work should be published in a peer reviewed journal of repute.
6. Method of selection:
  - (a) The primary selection committee will consist of The President, Secretary and Convener Scientific Committee of VRSI. They will choose one or more names for this award. The CV of the proposed candidates will be invited and will be examined by this Committee.
  - (b) The name or names chosen will be forwarded to another committee consisting of one eminent retinal expert from our country and one from outside the country. The recommendations of this committee will be final and binding.
  - (c) At primary or at secondary level if the selectors feel that none of the nominees deserve the award, the award can be withheld for that particular year.
7. The name of donor Dr. B. Patnaik will not appear on the citation but will only be mentioned in the print i.e. circular and the programme of the conference as below.

8. The travelling expenses in India and hospitality arrangements will be made by Vitreo Retinal Society of India.
9. The awardee will be conferred honorary membership of Vitreo Retinal Society of India.

Governing Council announced that the XVII Annual conference of VRSI will be held at Raichak on December 4-6, 2008 and Dr. Debnath Chattopadhyay will be the Organising Secretary. Dr. Debnath Chattopadhyay presented regarding the Venue and other logistics. The Governing Council also announced the venue for 2009 VRSI meeting, will be held at Palampur on December 3-5, Dr. Sangeet Mittal will be the Organising Secretary. General body welcomed the decision.

There was formal request from Dr. Hemanth Murthy to hold the conference at Koorg. He was asked to come up with the logistics and the allotment for 2010, to be discussed in the next GBM meeting. Dr. Natarajan offered to hold the meeting in Mahabaleswar in 2010, if Dr. Hemanth Murthy can not hold it in Koorg.

The issue of having association with other international societies has been discussed. General body formally agreed to have the association. Dr. R V Azad offered to help in having association with SAARC Academy Meeting and Asia Pacific Society of Retina Specialists. Dr. Natarajan agreed to work on association with EURETINA and ASRS.
